As per minutes of the Board meeting held on 14.05.18, persons with liability of Rs.40,000 & above and those having Vigilance/Police/Disciplinary cases are to be considered for promotion only after the finalisation of those cases.

As such Sri. C Mukundan Pillai, Junior Assistant, Ottappalam Depot, Palakkad was not given promotion to the cadre of Senior Assistant-II since he had been reported with a liability of Rs.7,33,447 and due to his involvement in a vigilance case.

Aggrieved by the denial of promotion, Sri. C Mukundan Pillai filed WP (C) No. 21288/18 before the Hon. High Court. The Hon. High Court in its judgment vide read 3<sup>rd</sup> above found that the denial of promotion to Sri. C Mukundan Pillai is illegal since the liability against him is stayed by the Hon. Court vide order dated 23.06.16 in WP (C) No.20062/16, and the vigilance case is said to have been registered as Crime No. 2413/14 is one in which no charge sheet is filed against him by the VACB.

Therefore the Hon.High Court ordered to consider Sri. C Mukundan Pillai for promotion to the post of Senior Assistant-II on the basis of his seniority with effect from the date of promotion of his immediate junior.

Sri. C Mukundan Pillai is at Seniority No. 190 in the existing Seniority list of Junior Assist ants. Sri.Shaji S, Seniority No. 192 is the immediate junior of

Sri. C Mukundan Pillai to whom promotion to the cadre of Senior Assistant-II was granted vide read 1<sup>st</sup> above. As per judgment, Sri.C Mukundan Pillai is eligible for being promoted to the cadre of Senior Assistant-II with effect from the date of promotion to his immediate junior. i.e. w.e.f 05.06.2018. The vacancies in the cadre of Senior Assistant-II up to 31.07.2018 have been filled by promoting three Junior Assistants vide read 2<sup>nd</sup> above.

The details are as follows.

Since no vacancy in the Senior Assistant-II cadre exists, the junior most incumbent who was promoted to the cadre of Senior Assistant-II, should be reverted back to the cadre of Junior Assistant.

In the above circumstances the following orders are issued in compliance of the judgment vide read 3<sup>rd</sup> above.

- Sri. K Abdul Latheef, Seniority No.304 (Tirur, Kozhikkode) is reverted back to the cadre of Junior Assistant.
- The date of order of promotion of Sri. S M Abdul Kabeer, Seniority No. 299 (Munnar, Kottayam) is changed from 05.06.18 to 14.08.2018.
- Sri. C Mukundan Pillai is provisionally promoted to the cadre of Senior Assistant-II in the scale of pay 25200-650-27800-700-29900-800-33900-900-37500-1000-42500-1100-48000-1200-54000 (Revised) w.e.f 05.06.2018. He will be on probation for a period of 01 year within a continuous period of 02 years with effect from the date of joining in the promoted post. He is entitled for benefits of promotion only from the date of joining in the promoted cadre.

- He is allotted to Ernakulam Region. The Regional Manager, Ernakulam will give suitable posting to the incumbent.

The officer concerned will relieve Sri. C Mukundan Pillai , JA after observing all usual formalities with direction to report for duty before the Regional Manager , Ernakulam.

All other conditions stipulated in the order dtd 05.06.18 & 14.08.18 will remain unchanged.

The judgment in WP (C) No. 21288/18 dtd 07.08.18 is complied accordingly.
