There are 24 vacancies remain to be filled in the cadre of Senior Assistant-I including vacancies in NFSA Depots.

The condition of declaring probation in the cadre of Senior Assistant.II has been excluded by Govt. vide order read as 2<sup>nd</sup> above but the one year experience mandated vide read as 1<sup>st</sup> above for promotion as Senior Assistant.I still exists.

Earlier, as per minutes of the 425<sup>th</sup> meeting of Board of Directors held on 14.05.2018, persons with liability below Rs.40000 and those who have no Police/Vigilance cases/disciplinary action pending were only considered for promotion.

The Hon.High Court vide read as 3<sup>rd</sup> above directed to consider the case of Sri.Rajeev Kumar T, Senior Assistant.II, Trivandrum Depot for promotion as Senior Assistant.I in accordance with his eligibility irrespective of the decision of the 425<sup>th</sup> meeting of Board of Directors held on 14.05.2018 provisionally and subject to further orders with in a period of one month.

Hence it has been decided to implement the order of Hon.High Court dtd 14.10.2019 and also to extend the benefit of Hon.Court's direction in similar cases de hors the decision dtd 14.05.2018 of Board of Directors.

In the above circumstances, the following employees, who have completed the mandatory period of one year in the cadre of Senior Assistant-II, are provisionally promoted to the cadre of Senior Assistant-I in the scale of pay 27800-700-29900-800-33900-900-37500-1000-42500-1100-48000-1200-54000-1350-59400.

The order of Hon. High Court dtd 14.10.2019 in WP (C) No.27089/2019 (I) is complied with accordingly.

The Regional Managers should give suitable posting to the individuals in NFSA as well as General category and report compliance in due course.
