Govt. vide order read as 1st above have ordered to curtail deputation of employees from Civil Supplies Department to the cadre of Senior Assistant.II in SUPPLYCO by 10% per year. Govt. have also issued guidelines vide order read as 2nd above for implementation of the order read as 1st above and fixed the no. of posts of Senior Clerks on deputation in SUPPLYCO.

Accordingly the no. of deputation posts of Senior Assistant.II in SUPPLYCO for the year 2020 should be 245.

The Senior Administrative Officer, Civil Supplies Department vide order read as 3rd above had reverted Senior Assistant.II from SUPPLYCO.

Consequent on this, 27 vacancies have been arised in the cadre of Senior Assistant. II in SUPPLYCO.
